The other Office bearers of ISA could not attend the meeting. However, Dr A.K. Vyas, Vice-President, ISA and ADG (HRM), ICAR, New Delhi was contacted in his office by the ISA President office. It was informed that he is presently not in the office.

At the outset, the President, ISA and Chairman, ASRB extended warm welcome to all the Executive Council Members and thereafter agenda items were discussed.

- Confirmation of the minutes of the last EC meeting: Minutes of the last EC meeting held on 20
 December, 2016 were confirmed.
- Printing and dispatch of ballot papers of Biennial Election of the ISA: The Executive Council decided
 to get the ballot papers printed and dispatched to voter members by the Returning Officer's Office by
 Registered Post/Courier.
- 3. Counting of ballot papers: It was unanimously agreed by the Executive Council members that counting of the votes will take place at the Headquarter of Indian Society of Agronomy as per schedule in the presence of the EC members and contestants or their representatives.
- 4. Payment of the Event Manager: The Executive Council members unanimously decided to approve the decision taken by the verification committee in respect of payments to the Event Manager. Now the secretary and treasurer may accordingly settle the payments to Event Manager.
- Scientist, Division of Agronomy, IARI, New Delhi to the Returning Officer raising the question of the credibility of the Returning Officer. The EC members unanimously highly condemned such type of activities by a member and agreed that EC will not entertain any such type of letters in future. Any member indulging in activities against the interests of Society, which tarnish the image of the Society and create hindrance in the smooth functioning of the Society, shall discontinue to be a member of the Society. The Executive Council henceforth will discuss such cases on merit and refer the matter to the General Body Meeting as per Society by-laws mentioned in the Clause 4.3 of the Constitution of ISA.
